Approximate Time Expectations/Season Overview:

- <u>May:</u> Tryouts/Initial Evaluations, & Acclimation: Program members will be expected to make corrections according to what
 was noted at tryouts and start conditioning/strengthening for the season. Fittings for fall camp-wear and uniform attire will be
 scheduled.
- <u>Summer:</u> Skill Building, Conditioning: Program members will be expected to improve upon the skills demonstrated at tryouts in an effort to be prepared for camps. Athletes are expected to attend all scheduled practices and OE camps (4x/week) unless prior approval is given in advance by Coach Scholle. Camp selection has been made and dates and times have already been reserved. All athletes are expected to attend camp. Skills camp will be in house June 13-14 (8a-4p) and July (7/10-19); exact dates TBD (8a-4p) for all teams. An additional camp to begin learning performance components will take place in August. Failure to attend the camp in its entirety will result in football season performance suspension & being an alternate off the floor during competition season.
- <u>Fall:</u> Competitive teams will be chosen/set after a tryout in late October. Choreography camp for competitive season will be split into two parts; an evaluation done at a private clinic at OEHS in August (8/18-26 specific dates TBD) and then full choreography in mid-November. All cheerleaders are expected to attend the evaluative choreography camp and competitive cheerleaders must attend full choreography. Failure to attend prescribed camps in their entirety will result in football performance suspension & being an alternate off the floor during competition season.
- <u>School Year:</u> 3-4 days of practices/week and games. Football games are every Friday night from August to early November. The cheerleaders will cheer at all home and away football games; assemblies; and participate in the Homecoming activities. Basketball games are mostly Tuesday and Friday evenings late November through February. The cheerleaders will cheer at all home conference games and the teams will split to share away game responsibilities. <u>ALL GAMES AND PRACTICES</u> ARE MANDATORY!!!

Financial Expectations (include but not limited to):

- Athletic fees (Fall \$65 / Winter \$300)
- Super CDA camps \$300 (Skills & Choreo)
- Summer OE Camps \$130 each session (Tumbling, ASP, & Cheer)
- Tumbling costs approx. \$300
- Shoes \$90 (Athletic/Comp. season)

- Practice attire \$60 (to be worn at camps and practices)
- Warm-ups, other accessories (hoodies, bows, socks, bags) – \$500 (as needed)
- Uniforms/accessories \$200-300

Expectations of a Cheerleader: *full details can be found in the OEHS Cheer Constitution*

- Dress appropriately and attend all practices, games, summer camp and clinics unless the absence is communicated by a parent & excused (see contract for what constitutes an "excused" absence) by the coach in advance.
- Be on time to all games and practices and have timely transportation home at the conclusion of practices and games.
- Work to your potential at all times & commit to consistent improvement of skills as evidenced by skill check evaluations.
- Learn & master all the material (sidelines, expectations, choreography, etc).
- Conduct yourself in the classroom on the field/court, in public in a way that reflects positively on you, your school and your squad
- Work as a member of your team & respect all authority figures, including the captain(s).
- Participate in fundraising activities (IRCA Competitions, OE ICCA Invitational, Mini-Cheer camp, Prairiefest Face Painting)
- Be responsible for cleaning, repairing, and/or replacing any part of the uniforms(s) if damages occur beyond "wear and tear."
- Follow all IHSA and/or National Federation Cheerleading Safety Rules; the Oswego School District 308 Code of Conduct and OEHS Cheer Constitution.

Not meeting expectations could result in the following:

- Conditioning
- Being released from practice
- Suspension: Being benched from game, performances, competition
- Having a conference with the athletic director, principal, and/or parents
- Dismissal: Repeated violations of the cheerleader expectations may result in being removed from the program
